As I, the named parent or legal guardian of the named participant(s) who is under 18, consider entering into catchair play center and/or participating in any parties, walk-in play, or any programs at Catchair, on behalf of the minors identified on this form, I acknowledge, appreciate and agree that

1. All children equipments at Catch Air including Inflatables, playground, exercise equipment and other toys can be hazardous and dangerous. Activities require various degrees of skill and experience. I understand that these activities can result in serious injury, death, illness to the person or child. I promise to accept and assume all responsibilities and risk for injury, death, and illness to myself and identified minors on the Catchair's premises.
2. I am aware of **age and weight limit** of certain activities for the safety of different age group of children at Catchair.
3. I hereby voluntarily release, waive, and forever discharge and covenant not to sue Kidz Pros L.L.C. d/b/a Catchair and its owners, agents, employees, officers, and all other persons or entities acting on its behalf, from any and all claims, including but not limited to alleged claims of negligent act or omissions, actions, rights, damages, liabilities, costs or expenses including attorney fees which are related to my child's participation or use of the Catch Air facility.
4. I hereby certify to be financially responsible to any physical or emotional injury or health concern incurred on Kidz Pros L.L.C. premises by myself or those whom I sign responsible for.
5. I hereby certify I, and those whom I sign for, are assuming all risk that may potentially be associated with any past injury or physical condition.
6. I understand Kidz Pros L.L.C. is not responsible for the negligence of other participants and those whom they are responsible to.
7. Kidz Pros L.L.C staff are not responsible or liable for recognizing a participants ability to safely participate in a given activity. It is the sole discretion of the parent or guardian to appropriately ascertain their child's capabilities.
8. By signing this agreement, it is my intention to assume all risk of injury and I do surrender and waive any rights to sue or exercise any legal right to seek damages against Kidz Pros L.L.C. d/b/a Catchair, its owners, agents, employees, and/or all other persons or entities acting on its behalf.
9. I acknowledge that my or my child's participation in activities at Catchair is voluntary. I hereby certify that I am over 18 years of age. I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had an opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risks and wave and release all substantial rights that I may have possess.
10. I agree to follow the rules as explained: No outside food, and all guests are required to wear socks. I understand that failure to adhere to these rules may result in being denied service. If denied service, guest admission will not be refunded.
11. Photos and use of recording devices by staff may be used on premise and images and videos may be used for marketing and security purposes.
12. I hereby understand that Kidz Pros L.L.C. will not be held responsible for any and all lost or stolen items.
